

TERMS AND CONDITIONS FOR EAST MALAYSIA PARTNERS X BOOST BANK PROMOTIONAL INTEREST RATES: UP TO 5.0% P.A. (1 OCTOBER 2024 - 31 OCTOBER 2024), UP TO 4.0% P.A. (1 NOVEMBER 2024 30 NOVEMBER 2024) AND UP TO 3.6% P.A. (1 DECEMBER 2024 - 31 DECEMBER 2024) FOR EAST MALAYSIA JARS CAMPAIGN ("CAMPAIGN")

This Campaign is held by Axiata Digital eCode Sdn. Bhd. (Company Registration No. 201701000820 (1214970-T)) ("eCode") in collaboration with Boost Bank Berhad (f.k.a. Boost Bhd) (Company Registration No. 202301007223 (1501144-T)) ("Boost Bank"), Servay Hypermarket (Sabah) Sdn. Bhd. (Company Registration No. 199701016232 (0431729-H)), Bataras Sdn. Bhd. (Company Registration No. 199801017117 (0473246-D)), CKS Retail Sdn. Bhd. (Company Registration No. 199301015847 (270587-H) and Farley (KS) Sdn. Bhd. (Company Registration No. 201501017122 (1142456-H)) (collectively referred to as "East Malaysia Partners"). By participating in the Campaign, Customer (as hereinafter defined) hereby agrees to be bound by these terms and conditions which shall form an integral part of and to be read together with Boost Bank's Personal Banking Terms and Conditions, Boost Bank Debit Card Terms and Conditions and eCode Terms and Conditions.

In the event of a conflict or inconsistency between these terms and conditions, such inconsistency shall be resolved by giving precedence in the following decreasing order (i) these terms and conditions; (ii) Boost Bank's Debit Card Terms and Conditions, (iii) Boost Bank's Personal Banking Terms and Conditions; and (iv) eCode Terms and Conditions.

eCode and/or Boost Bank reserve the right to withdraw, amend, omit and/or vary any part or the whole of the terms and conditions of this Campaign with prior notice to the Customer and the Customer shall be bound to observe, perform and comply with the terms and conditions herein and any amendments thereof. eCode and/or Boost Bank's decisions in any matter in relation to this Campaign shall be final and conclusive.

Campaign Period

1 October 2024 until 31 December 2024

Eligibility

This Campaign shall be applicable to all account holders who: (i) open and maintain Digital Savings Account (as defined in Boost Bank's Personal Banking Terms and Conditions) with Boost Bank; and (ii) fulfil the criteria set out in this Campaign during the Campaign Period ("Customers").

Important Notice:

- 1. By participating in this Campaign, you hereby acknowledge and agree to:
 - (a) the terms and conditions of the following Campaign set out below; and

- (d) access Boost Bank's website on a regular basis to view all relevant terms and conditions (including any related notices). You must seek clarification from Boost Bank's authorised representatives if you do not understand any of these; and
- (e) The total deposits received will have a maximum cap of RM250 million ("Maximum Cap"), shared among the East Malaysia Jars (as defined below) on a first come, first served basis. If the Maximum Cap is reached, the Customers will not be eligible for the Promotional Interest Rate (as defined below). Boost Bank is not required to notify the Customers when the Maximum Cap is reached.
- (f) allow and authorize eCode to disclose the following details to Boost Bank for purposes of determining the Customers' eligibility to receive the Promotional Interest Rate (as defined below):
 - (i) your eCode registered name and phone number;
 - (ii) your National Registration Identity Card number;
 - (iii) your transaction amount and date (paying with Boost eWallet), without first obtaining any further consent from you nor making any payment whatsoever to you.
- (g) In the event that you disagree to have your details as set out in paragraph 1 above to be disclosed by eCode, you shall email to marketing@myboost.co to express your disagreement and decision to be opted-out from the following Campaign. In such instances, you have opted-out from and no longer be eligible to receive the offer/reward under the following Campaign.

Campaign Mechanics

- 1. During the Campaign Period, the Customers who:
 - (a) open and maintain Digital Savings Account (as defined in Boost Bank's Personal Banking Terms and Conditions) with Boost Bank;
 - (b) perform at least one (1) transaction with minimum spending of RM50.00 each transaction at any physical outlet of the East Malaysia Partners in a calendar month; and
 - (c) pay with Boost eWallet and/or via Boost Bank Debit Card,

are eligible for a 5.0% per annum daily interest on their savings ("**Promotional Interest Rate**") in each of the four (4) jars, namely Servay Jar, Bataras Jar, CKS Jar and Farley Jar, collectively known as "**East Malaysia Jars**" which will appear automatically upon the Customers fulfilling the aforementioned criteria in paragraph 1 above. The interest payments will occur daily.

For the avoidance of doubt, the Promotional Interest Rate is only applicable to the end-of-day balance of the East Malaysia Jar and not applicable to the end-of-day balance of the main account and other Saving Jars of the Customer. All interest payments made under this



Campaign are subject to applicable taxes and Boost Bank will deduct any required taxes before crediting the interest to the Customer the East Malaysia Jar.

- 2. For absolute clarity, during the Campaign Period, if a Customer does not fulfil the criteria in paragraph 1 above in the following month after the first transaction qualifying for receiving the East Malaysia Jar, the Customer is not eligible to receive the Promotional Interest Rate for that following month, and the amount then in the East Malaysia Jar will be credited automatically into his main account and the East Malaysia Jar will continue to appear but will be deactivated. However, if the Customer fulfils the criteria in paragraph 1 again during the Campaign Period, the Customer's East Malaysia Jar will be reactivated and the Promotional Interest Rate may apply to the end-of-day balance of the then East Malaysia Jar, subject to the Maximum Cap.
- 3. The maximum amount an eligible Customer may deposit into each of the four (4) East Malaysia Jars is capped at RM25,000.00 only.
- 4. The Promotional Interest Rate for the East Malaysia Jars will be reduced to 4.0% per annum commencing from 1 November 2024. On 1 December 2024, the rate will be further reduced 3.6% per annum. Upon expiry of the Campaign Period, the East Malaysia Jar will automatically be closed and the amount then in the East Malaysia Jars will be credited automatically into the Customer's main account.
